Kalliopé launches a sponsorship programme aimed at promoting committed emerging artists

The last mountain weather station in France offers a unique landscape evoking to the artist "*the intimate struggle between spirituality and rationality*" and symbolises, in his view, "*a thought that is all the more political at a time when climate change is having its first effects on Western lifestyles*".

The ephemeral decor made possible by this sponsorship is hung on the walls of the new Paris headquarters of Kalliopé, which are located in the 8th arrondissement and in which the team moved last May. A wider selection of his artwork from the series can also be viewed on the new website of Kalliopé, which inaugurates its new identity at the same time.
